#### 10. Scorecards:

## 11. Transgender Policy:

A transgender policy from Bowls NZ was circulated and discussed. This has been accepted by Sport New Zealand. Permission to change the document will be sought from Bowls NZ and adopted by NZIB.

## 12. Police Vetting:

The Executive went into Committee for discussion for 15 minutes.

Topics to be considered admin, coaching/umpiring, funding, attracting new members, retention of members and administrators, district challenges plus any topic the district would like to discuss.

#### 16. Databases:

An issue with the Access database has been identified. Graham Low has contacted someone In UK who can alter to what we are requiring at approximately \$1,200. Executive members are asked to investigate other database systems and reply within 3 weeks.

Copies of the current database for each district will be sent to them to be updated and returned.

# 17. Umpires Exams:

Nigel Warnes will continue as examiner. Interest is to be sought from all Districts for people wishing to undertake the umpires' exams in March to be returned to office by 20<sup>th</sup> April 2021. The exam will be in the first week of May.
