9. **AGM**

In view of the situation with Covid-19 it was agreed that there should be an expectation that all delegates to the AGM should be double vaccinated and able to produce the Covid certificate. Helen to contact all district secretaries to ensure delegates are aware of this criteria.

One remit has been received from Tauranga re changing the qualifying points from 6 to 5 at the National Championships. The Executive does not support the remit as the proposed concept opens the door to manipulate results and it loses the sight that many players attend the Nationals to meet friends and have a holiday and do not wish to be bowling every day.

10 Annual Report:

11 Revision of Law Book:

There has been one submission from Canterbury Catholic Association through the Canterbury District. Clause 9 is already covered in the current law book – no part of the person may be on the mat.

There is also a remit from the Executive to change rule 14.

"That Rule 14 be changed to "önce the last bowl of the end has been released players may walk up the side the mat"

Rule 24: Measuring during the end: No Measuring devises or items used to determine shots may be placed between the bowls **or** on the mat prior to all bowls being played in that end. The eyes only may be used. "

12. **Capitation 2022:**

"That the NZIB recommends to the AGM a District levy system based on 2021 numbers for each district. This is to provide certainty to both the Districts and the NZIB for levies for the next 3 years. Should this recommendation not be passed by the delegates at the AGM the Executive recommends membership to be levied at \$25 per full member and \$5 per student member."

13. Certificates, badges, plaques:

Following discussion at the forum during the National Championships generic A4 certificates will replace all certificates used at present. Medals for winner, runner up and third equal will replace the badges for National Championships, Junior singles and National Championship plaques will be phased out. Winner and Runner up medals will be presented for 1-5 Singles, 1-5 Pairs, Mixed Fours, Mixed Pairs, Masters Fours and Henselite Champion of Champion Singles. Display cases are to be investigated for purchase by medallist if wished. Graham Low to contact Moller and Young, Helen to approach Distinctive Badges and Alex Trophies.

15. **International:**

Graham Low has been in touch with Joe Simpson in Australia regarding a Trans Tasman. Australia have started on selection processes for their team. A nomination form to be sent to all district secretaries ASAP with a closing date on 4th December 2021. The tour will only be able to proceed should there be no quarantine requirements on either side of the Tasman plus all players/manager etc will need to be double vaccinated to fly. Proposed dates are assemble Auckland Friday 6th May, arrive Australia Sunday 8th May Practice 9th -11th May, tests 12-14th May return home Sunday 15th May.

19. Welch Trophy Format:

Michael Lawson tabled a proposal for the Paterson and Welch Trophy moving forward. Feedback on the proposed format outlined last year at the AGM has been listened to and the format modified. Divisions would be based on the 2021 Paterson results.

With the current state of Covid in Auckland and other areas it is not feasible to play the postponed events in 2021. Proposed that all postponed events, excluding the Welch trophy, to be played on one Super Weekend 22nd - 25th April. Wayne to investigate whether Expressions in Upper Hutt would be a possibility to host.

21. Draft 2022 Programme:

Graham Low produced a draft programme for 2022. Some changes were discussed and it was agreed to hold a Super Weekend for the finals of all events, excluding Paterson and Welch, from 9th - 11th September 2022.
