10. INTERNATIONAL EVENTS UPDATE:

12. APRIL SUPER FINALS WEEKEND:

The Event Controller said that the weekend had gone very well and feedback had been generally very good. Some Masters Fours players asked if their event could be played in the same, seven rounds complete round robin, which the other events are played under. No issues were deemed likely from this and Graham will change the conditions of play to reflect this.

The junior players in the Junior Singles had enjoyed watching and being watched by the senior players, and while the Junior Singles will be played in August this year the same weekend as the Secondary School Singles and Pairs, a new Junior Pairs was mooted. This would not go on the Calendar until 2023, but could be played on a regional basis with zone winners going to the National final. This proposal will be considered further.

13. NORTH TARANAKI

Taranaki queried why the runner up of the Henselite Champion of Champion for the zone could not have replaced the player who withdrew.

The rules state for 'sickness and work-related commitments. The decision to just not go and play the event is not covered. An email had been received on 6th March that the player had decided not to play bowls this season and was therefore withdrawing. This not only created a bye but also punished the other players in the zone by leaving them unrepresented at the event. A request for payment for the flight from the player has been refused. To be followed up.

14. WELCH TROPHY 2022:

The 2021 Welch Trophy event will be played 16th - 18th September in Hamilton. Flights will be booked through Air New Zealand and names will need to be supplied by winners just prior to the event. NZIB will seek funding in the meantime. A request from Hutt Valley to organize their own travel was turned down as if funding is obtained we will need to be making the bookings. Quotes for bus travel from Auckland to Hamilton return is also being sought.

GENERAL BUSINESS:
