GENERAL BUSINESS:

1. Nationals 2023:

David Edgar reported on a successful New Plymouth Nationals.

Very pleased with increase in entries across all events. No major issues encountered during week and most feedback positive. Matside commended for providing excellent coverage Miniature trophies to be replaced with updated District details. Delwyn Hughes Trophy for Masters Challenge has been located. Special thanks to Ron and Rae Inglis for their sponsorship of the 'Feature Game' - a potential new sponsor is in the wind. Noted that NZIB banners were not utilised.

2. North vs South:

Funding application for accommodation declined. Air NZ flight bookings confirmed with all players arriving by lunchtime. Lunch on Saturday confirmed for venue - evening meals for Friday and Saturday to be confirmed. Accommodation - North at Taylors, South at Adcrofts. Unform orders to be placed for new players and any upgrades as advised. Reserves to be supplied with shirts. Year bars and Island Representative badges to be ordered. Umpire will be able to assist with updates in Chartroom.

3. 'Super Finals' Weekend:

Draft programme to be published on the NZIB website and Facebook pages. All players to be contacted midweek to confirm travel arrangements and book airfares. Accommodation arranged for all players at Brentwood Hotel, Kemp Street, Wellington. Venue confirmed as Wellington Indian Association premises (walking distance from accommodation). Controller - Wayne Tough. Meal arrangements to be confirmed.

4. Inter-Provincial Events:

Venue confirmed as Akau Tangi Sports Centre (formerly ASB Sports Centre) Kemp Street, Wellington. Three local Districts have been advised of their responsibilities during this event, including - supply and setup of mats and bowls, umpires and administration. Controller - Chris Lander? Meals at all four venues to be provided by host Districts with costs to be advised to participating teams. Lunch availability at venue for Divisions 1, 2 and 3 to be confirmed, alternatively Brentwood. Suggested schedule for play at respective venues - Division 1, 2 and 3, Wellington and Division 4 South, Timaru - Friday (Round 1), Saturday (Rounds 2-4) and Sunday, (Round 5). Division 4 North Section 1, Hamilton - Saturday only. Division 4 North Section 2, Napier - Saturday and Sunday.

5. NZ Junior and Secondary School Events:

Respective events tracking as expected. NZ Juniors on Sunday 27th August in Auckland with entries closing on 17 July. NZ Secondary Schools Singles and Pairs follow on Monday and



Tuesday. Request from Otago to extend the closing date for South Island Secondary Schools competition approved.

6. Trans-Tasman International 2024:

Applications received from Southland and Counties to host 2024 event. The standard set by Southland as hosts for 2019 event was acknowledged. Important for host districts to understand how Trans-Tasman event can be of major benefit for promotion of our sport.

7. Bowls NZ Contract:

President Michael Lawson extended an apology to all Districts for the delays in responding to emails and communications with NZIB. Michael also acknowledged the efforts of NZIB Executive members during difficult times since the passing of Helen. NZIB has been struggling to cope at the busiest time in our sport and that the Executive was dealing with much of the business normally expected to be done by Bowls NZ. Members expressed some concerns and requested a meeting be held with Bowls NZ. Existing contract with Bowls NZ has been extended to September in the interim. NZIB to review administration duties and future requirements at October meeting.

8. Zone Finals Substitutes/Replacements:

Bay of Plenty queried the decision on the 'replacement' ruling applied for Mixed Fours Zone Finals. Several Districts were similarly affected and NZIB would prefer that all Districts are represented in the Zone Finals. Needs to be a level of flexibility in rules to accommodate scheduling of District events and that some local qualifying events leading to Zone Finals are being played under differing 'Conditions of Play'. Winning combinations from the Zone Finals, however, need to ensure all players are available for the NZ Finals competition.

"That in the 'spirit of the game' District competitions be considered as separate events, and rules amended accordingly to clarify use of substitutes/replacements".
