

PRESIDENT'S REPORT

As a group, we need to come together and put much more into this one area of promoting our sport, either through membership drives or our events being broadcast to a larger audience. The 2023 Executive has been nominated, unopposed, for the coming year to govern our sport and make decisions that they believe are in the best interest of ALL members. Not every decision the Executive takes will be popular with all stakeholders, or guarantee a successful outcome, but without the freedom to try a new or different approach in various areas, how will we ever know what can be achieved? To those that enjoy the security of hiding behind a keyboard whilst attacking the people that are giving up an enormous amount of their personal time for the game we all love, I encourage you to work constructively with those same people for the betterment of the game. Actually, why not stand up and look to gain a seat at the Executive Committee's table and, therefore, be in a position to help make positive change. Visiting Facebook would be a

much nicer experience if it was full of positive stories from all our districts and would certainly make better reading by potential sponsors that are considering attaching their brand to ours.

In May of this year we were all very saddened by the passing of Helen Stallard after a brief illness. Helen was my rock throughout my term as President, and I must say that the Executive, especially myself, struggled for a large part of the year due to her absence. We did, however, get through to the end of the season. Perhaps not as perfectly as I would have hoped, but we got there. It is amazing to realise just how much one person achieves in the background, and it was certainly due to the loss of her institutional knowledge that we missed the mark in a few key areas of the operation. Perhaps we have lost a bit of respect over some issues, but I'm pretty proud of the hard work that the Executive has done to make sure we didn't drop every ball without Helen's presence.

To all the districts that ran our events and continued to provide support for the clubs in your respective areas of the country, I offer a big "thank you".

I thank the whole Matside team, especially Joy and Dave Archer, for what you have done for our sport. Matside's live-streaming of our events will, I hope, continue to be a major part of our sport and a key component of our growth.

To all umpires, coaches and everyone who stands up to help at district and club level, thank you on behalf of the Executive.

To the Executive Committee: Graham, David, Barry, Liz, Roy and Wayne, thank you for your selfless commitment over the past year. I wish you all the best for the coming season.



Club of the Year: The Mount Junior Club - Tauranga

Six years ago, a dream was mooted of having a club for Intermediate age children competing in the Aims Games. After introducing the concept to some 35 classes there was tremendous interest in a game which allowed all to participate.

Along with new skills the players have learnt to govern their club with assistance from adults when and if required. Four members have achieved in Senior competitions. Junior Club members are now assisting in exposing the sport to local schools accompanying adults to 'Have a Go' days.

Statement of Other Material Information

New Zealand Indoor Bowls Incorporated For the year ended 30 September 2023

1. Statement of Accounting Policies

Reporting Entity

The special purpose financial statements presented here are for New Zealand Indoor Bowls Incorporated. New Zealand Indoor Bowls Incorporated is an incorporated body established for promoting and administering indoor bowls in New Zealand.

Basis of Preparation

The annual report is a special purpose financial report that has been prepared in accordance with the accounting policies disclosed and in order to meet the requirements of the Tax Administration (Financial Statements) Order 2014 and for the benefit of New Zealand Indoor Bowls Incorporated's members.

Measurement Base

The financial statements of New Zealand Indoor Bowls Incorporated have been prepared on an accrual basis and are based on historical costs. The information is presented in New Zealand dollars, rounded to the nearest whole dollar.

Changes in Accounting Policies

There have been no changes in accounting policies. All policies have been applied on a basis consistent with those of the previous reporting period.

Specific Accounting Policies

a) Property, Plant & Equipment

The entity has the classes of fixed assets as shown on the Schedule of Fixed Assets and Depreciation. All fixed assets are recorded at cost less accumulated depreciation.

Depreciation of the assets has been calculated for at a rate intended to write off fixed assets over their useful life as follows:

b) Goods & Services Tax

d) Payables

Payables are recognised at fair value and represent the amount outstanding by New Zealand Indoor Bowls to its suppliers and employees at balance date.

e) Taxation

New Zealand Indoor Bowls Incorporated is exempt from income tax in terms of section CW46 of the Income Tax Act 2007, as a body promoting amateur games or sport.





f) Income

Capitation and affiliation fees are recognised when received. Grant and sponsorship funding is recognised on an accrual basis to match the funding period.

Sponsorship income is recognised when the invoice is raised.

Equipment sales are recognised when the associated purchase of equipment invoice is raised.

g) Interest Received

Interest income is recorded on an accrual basis.

3. Contingent Liabilities

At balance date there are no known contingent liabilities (2022: \$nil).

There was no overdraft as at balance date nor was any facility arranged.
