FUNDING REPORT:

MEMBERSHIP AND AFFILIATION FEES:

- Affiliation Fees
 - o Thank you to the Districts for prompt payment of the 2025 Affiliation Fees.
 - o District are required to pay the full invoiced amount by the Due Date. If the Hardship Request is approved, a refund for the difference is then processed.
- Membership Returns
 - o No Membership Return has been submitted by Auckland or Northland.
 - o Incomplete Membership Returns have been submitted by Canterbury and Waikato.
 - o The District Membership Return data has now been uploaded into the Sporty CRM. A quality review of the data will be completed before December.
 - o The 2025 Membership Return outlined the minimum required data for every affiliated member. Some Districts have not provided all this data in 2025, which is acceptable, however all future Membership Returns must meet the minimum data requirements.
- Hardship Requests
 - o It is of concern to the Executive that a pattern is emerging with some Districts repeatedly applying for Hardship Requests.
 - o Future Hardship Requests will not be accepted without a detailed plan to recover from the drop in membership numbers.
 - Horowhenua An offer of Executive mentorship has been extended to this
 District. The outcome of their Hardship Request is subject to their engagement
 with this offer.

- Waikato This request will be reconsidered in December pending submission of the outstanding Club Membership Returns.
- Northland This request will be reconsidered in December pending submission of the outstanding District Membership Return.

HEALTH AND SAFETY REPORT:

- Incidents and Observations
 - A fall (no injury) was reported at the Super Weekend as the result of a player stepping backward onto a bowl on another mat.
 - o Concern was raised about 'wind-up and dangerous drives'.
 - Regular health and safety moments on social media and newsletters would be an appropriate way to remind members to be health and safety vigilant.
- The Safeguarding of Children and Vulnerable Adult's policy was discussed.
 - o Graham Low commented that there was information repeated throughout the document and that perhaps this could be simplified. A further review of the document does show repetition however, as the Executive elected to adopt the Sport NZ policy, it is recommended that no further changes be made.




